relies upon open plan kitchen meals and lounge (KML)
L2: 2 bed (U1, U2, U3), KML (U4), roof (U5)
L1: KML (U1, U2, U3), 2 bed (U4, U5)
GND: 3rd bed disguised as "study" (U1), KML (U5)
P: shared garage (U1, U2) single garage (U3, U4, U5)
NON VENTILLATED BATHROOMS (U4)
NON-VENTILLATED L'DRY (U1, U2, U3)
NEW CROSS-OVER CONFLICTS WITH STREET TREE
U1 HAS 3RD BEDROOM DISGUISED AS "STUDY"
INSUFFICIENT PARKING
POOR INTERNAL AMENITY
SITE OVERDEVELOPMENT

requires 2 spaces, rule is 2 spaces to each 3 or more bed dwelling
requires 4 spaces, rule is 1 spaces to each 2 bed dwelling
requires 1 spaces, rule is 1 visitor spaces to each 5 dwellings
requires 7 spaces in total, and plans show 5 spaces






