The aim is to supply our members answers to question most important them in the hope it will aid their voting choices in the upcoming council election.

We have aimed to keep the impost on your time to a minimum by posing most questions for yes or no answers with some also asking how you might achieve the answer as a Councillor.

GENERAL RESPONSE

GOVERNANCE, ACCOUNTABILTY AND TRANSPARANCY

One of the glaring weaknesses of the majority of current councillors has been their inability/failure to accept that they represent the community. The following questions require a simple yes/no/how answer to demonstrate your commitment to important democratic procedures.

1. Will you support complete transparency in issues affecting the community?

HOW? All means possible, but mainly by committing to transparency on what I'm working on. I'll regularly publish what's on my to-do list for council – the issues I'm working on and by extension, the issues I'm not working on. I'll also push for greater use of

PLANNING AND DEVELOPMENT

HOW? Through height restrictions and working to retain the vibrant businesses that call Preston Market home.	

2. Will you support mandatory heights limits be applied to the Preston Market site?

3. Will you oppose the practice of trading off of objectives and standards, such as height limits in the planning scheme that can result in poorer outcomes but gets developments built in Darebin?

I'll seek to work closely with the State Government on this.</p> <p>On Council, I'll look to promote programs that drive tangible action on the climate:</p> <ul style="list-style-type: none"> ● Facilitate access to cheaper renewable power for local businesses -- e.g. bulk buying arrangements) ● Provide subsidies for households to buy batteries that allow them to store the solar energy generated by their solar panel systems ● Support households to transition away from gas usage – e.g. by providing subsidies to replace end of life gas hot water and stoves with electric ● Increase our tree cover, especially focusing on native regeneration to promote biodiversity 	

2. Will you bring policies to Council that will make a real improvement at a local level to Darebin's environment and biodiversity?

<p>HOW?</p> <p>I'll work to:</p> <ul style="list-style-type: none"> ● Increase native tree cover to promote biodiversity ● Improve the Council's litter collection service. There's too much litter in our parks and green spaces ● Lift the Merri Creek lower trail. It currently sits within the riparian zone and should be lifted, restoring indigenous vegetation, ensuring the path is above the flood zone and meeting width regulations 	

3. Darebin Council set up both Climate Emergency Darebin and the Darebin Nature Trust as key initiatives very early in their term. What do you know about these two entities and their specific achievements?

	Both groups have worked to raise awareness of the need for action on the climate emergency and lack of open space in Darebin.
